If the arbitrator rules in my favor, then I will be entitled to a refund for the difference between the amount charged by the towing company and the amount authorized by the arbitrator. If the arbitrator rules in favor of the towing company, then I will be responsible for the administrative expenses of the arbitrator and the full payment of all services.
